1. Introduction

Udai Pratap College recognizes the crucial role of Information Technology (IT) in enhancing the learning environment, administrative efficiency, and overall effectiveness of the institution. This IT Policy outlines the guidelines and principles governing the use, management, and evolution of IT resources within the college.

2. IT Facilities

2.1. Wi-Fi Facilities: The college provides campus-wide Wi-Fi connectivity to facilitate seamless access to online resources.

2.1.1. Current Status: The college provides comprehensive Wi-Fi coverage across all academic and administrative buildings. Wi-Fi is accessible to students, faculty, and staff, facilitating seamless connectivity.

2.1.2. Updation History: Completely upgraded on December 2021 to provide faster and more reliable internet access. New access point in Chemistry Department was added in January 2022, in Agriculture faculty in August 2022 to cover additional areas for improved connectivity. Multiple access points were added in Central Library to make Library fully Wi-Fi in January 2022.

2.2. Computer Labs: The College maintains state-of-the-art computer labs equipped with the latest hardware and software to support academic and research activities. Well-equipped computer labs are available for students and faculty. Computers are regularly updated with the latest software and security patches.

2.3. E-learning Platforms: The college utilizes modern e-learning platforms to supplement traditional teaching methods. Regular updates are conducted to enhance the functionality and user experience of e-learning tools.

3. Internet Bandwidth: Udai Pratap College is committed to ensuring sufficient internet bandwidth for academic and research purposes.

3.1. Available Bandwidth: The College provides 3×300 Mbps of internet bandwidth for its users. Bandwidth allocation is periodically reviewed to meet the growing demands of the college community.

3.2. Bandwidth Management: The IT section of the college employs bandwidth management tools to ensure fair and efficient use of available resources. Priority is

given to academic and research-related activities to facilitate uninterrupted learning experiences.

4. Security and Compliance

- 4.1. **Information Security:** The college prioritizes IT security to safeguard data, systems, and network infrastructure by implementation of firewalls, intrusion detection/prevention systems, and regular security audits, and secure network access controls to ensure only authorized users and devices connect to the network.
