It gives personal access to each user and has the option of giving purchase suggestions and feedback. The online availability and status of books can be seen by its users now on OPAC platform. The institute should keep up its regular subscriptions to new publications and periodicals. Teachers and students are asked for recommendations when they subscribe to the electronic resources.
